**Millennium Consolidated Holdings LLC Closes Private Placement of \$50.0 Million of Senior Unsecured Notes due 2023**

**Sandler O'Neill + Partners, L.P. served as sole placement agent for this offering.**

**This transaction represents the first institutional offering for Millennium Consolidated Holdings LLC and the 164<sup>th</sup> senior note or subordinated note transaction since January 1, 2014 in which Sandler O'Neill acted as a placement agent, sole underwriter or book-runner.<sup>1</sup>**

### About the Offering:

**CHARLOTTE, NC** – Millennium Consolidated Holdings LLC (“the Company”), the parent of Millennium Advisors LLC and Millennium Europe Ltd., closed the sale of \$50.0 million in fixed rate senior unsecured notes. The Notes have a maturity date of June 30, 2023 and carry a fixed rate of interest of 7.50% for the life of the issue.

Millennium intends to use the proceeds from the Notes for general corporate purposes, including to fund further organic growth in its U.S. and U.K. broker-dealer subsidiaries. The Company intends to use the majority of capital raised to on lend on a subordinated basis to its broker-dealer subsidiaries.
